Remote Meetings: On March 12, 2020, Governor Newsom issued Executive Order N-25-20, which enhanced State and Local Governments ability to respond to COVID-19 Pandemic based on Guidance for Gatherings issued by the California Department of Public Health. The Executive Order specifically allowed local legislative bodies to hold meetings via teleconference and to make meetings accessible electronically, in order to protect public health. That order expired on September 30, 2021. Governor Newsom has now signed AB 361, and the TAMC Board of Directors approved a resolution to enact AB 361 on September 22, 2021. This legislation permits teleconferencing for Brown Act meetings during a state of emergency. Thus, TAMC meetings will convene remotely, until further notice. 1. Chair Mike Novo called the meeting to order at 6:00 p.m. A quorum was established, and Maria Montiel took roll call.

2. PUBLIC COMMENTS

Committee member Martin Wegenstein mentioned that he attended a Carmel Valley meeting and a presentation on "Park It Program" was presented. He requested that TAMC staff ask the "Park It" program for a presentation at a future meeting date.

Committee member Natalie Popovich provided comments from Mari Lynch that the book "Cycling for Sustainable Cities" is in local public library now.

Ariana Green, Principal Transportation Planner, shared a letter from Paola Berthoin with the committee regarding desire for wider bike facility on highway 1 through Carmel. Ms. Green noted that she would forward the letter to committee members as it was not included in the agenda packet.

4. 2022 LEGISLATIVE PROGRAM

The Committee member received and commented on the draft 2022 Legislative Program.

Christina Watson, Director of Planning, reported that the legislative program helps guide staff and consultants in responding to legislative proposals. She reviewed the changes from the 2022 draft program, highlighting the items of particular interest to the committee.

The Committee had the following comments and input on the draft 2022 Legislative Program:

- Consider adding the word accessibility to 4S on the State priorities list
- Consider a future presentation from Monterey-Salinas Transit on the integrated fare system
- Consider looking into legislation related to the theft of e-bikes
- Consider clarifying in 1F(10) the word "resilient" and suggests using broader language on the Federal priorities list
- Consider including in 1F(10) disaster preparedness and evacuation considerations

5. COMMITTEE MEETING CALENDAR AND APPOINTMENTS FOR 2022

The Committee appointed a committee Chair and Vice Chair to serve a one-year term beginning January 2022 and adopted the 2022 Bicycle and Pedestrian Facilities Advisory Committee meeting calendar.

Ariana Green, Principal Transportation Planner reported that the Committee is responsible for appointing a Chair and Vice Chair to serve a one-year term in office. An election is held in November of each year pursuant to the Committee Bylaws. The proposed schedule of meetings for 2021 follows the existing pattern of meetings, occurring on the first Wednesday of the month, from 6 to 8 p.m., except for the months of July and December when all Agency committee meetings are cancelled. She noted that due to the Covid-19 pandemic, Committee meetings will continue to be held remotely pursuant to AB 361, that the COVID-19 pandemic state of emergency declared by Governor Newsom is still in effect. In the event meetings transition back in-person during 2022, TAMC will send a revised meeting calendar to all Committee members and any interested members of the public.

Committee member Eric Petersen nominated Committee member Mike Novo for the 2022 Chair and the motion was seconded by Committee member Martin Wegenstein.

Committee member Mike Novo nominated Martin Wegenstein for Vice Chair and the motion was seconded by Committee member Hans Hoffman.

Committee member Martin Wegenstein noted TAMC staff look at the list of the various meeting locations suggested at a recent agenda item. Ariana Green replied that Transportation Agency staff will check on those locations to see if available to meet on the future meeting dates if

Covid-19 restrictions are lifted and staff will contact committee member of any chances to 2022 calendar.

6. <u>ANNOUNCEMENTS AND/OR COMMENTS</u>

Committee member Mike LeBarre suggested the committee should re-named the grant program to "Active Transportation Advisory Committee" or something along those lines. He asked for an item to be agendized for discussion at a future meeting.

Committee member DL Johnson noted that there have been a lot of e-bikes in Carmel. He mentioned that he spoke with some Carmel staff to find out if there are any e-bike regulations and there aren't any yet although there have been some issues with theft. Committee member Wegenstein suggested the city of Carmel try bike valet parking.

Committee member Martin Wegenstein noted that new bike lanes on Carmel Valley Rd and invited all to come see them. He noted that the Monterey County Public Works narrowed the travel lanes to make room for the bike lane.

Committee member Jung Hwa Kim noted that the City of Pacific Grove has some ordinances around e-bikes, the main concern is with speed on the coastal trail. She also noted that some local bike rentals have been taking large groups of riders out in tour and into the neighborhoods.

Executive Director Todd Muck introduced the newest TAMC member Alissa Guther who will be working on bicycle and pedestrian planning issues.

Committee member Sloan Campi noted that he has some concerns with restrictions on e-bikes as they can be barriers to increased ridership.

Committee member Eric Petersen announced that Sea Otter Classic happened with some lessons learned and it will be back the first weekend in April. He suggested putting e-bike issues as a future meeting agenda item. He also noted that the California vehicle code set e-bike speed limits at 20mph. He suggested that everyone follow the State standards.

Committee member Ernie noted that e-bikes theft is an issue and has been around for a long time.

SUMMARY:

The Monterey County Bike Map was last updated in 2016 as part of the Regional Pedestrian and Bicyclist Wayfinding Program for Monterey County. The primary goals of the 2022 Bike Map Update are to add projects completed since 2016, identify preferred routes, and improve the map's usability.

FINANCIAL IMPACT:

Funding for the 2022 Bike Map Update includes \$16,000 of local funds in the approved Transportation Agency budget.

DISCUSSION:

The Monterey County Bike Map serves a wide range of bicyclists including those that commute by bike or ride for recreation. Bicyclists who use the map also range in skill level from those that are highly confident to those just beginning. Both locals and visitors use the Bike Map.

The Monterey County Bike Map is intended to help bicyclists get from A to B safely and efficiently and encourage bicycling by making a network of easy and comfortable bike routes accessible.

Staff is requesting input on ways to improve the bike map in general, as well as what amenities could be added to make the map more helpful. Input is requested for the following questions:

- Where should these maps be distributed?
- Who are the maps users?
- What amenities would be helpful to add?
- What is important to you when using the map?

SUMMARY:

The Bicycle Secure Program provided racks and equipment to support active transportation across Monterey County. Staff is requesting the Committee's input on updates made to the program, now called Active Transportation Support Program, Guidelines that would broaden the program to increase access to active transportation in the county.

FINANCIAL IMPACT:

The adopted Transportation Agency budget includes \$30,000 for the Active Transportation Support Program (formerly the Bicycle Secure Program).

DISCUSSION:

The Active Transportation Support Program formerly operated as the Bike Secure Program as an on-going, rolling grant program with the purpose of promoting active transportation by providing businesses, schools, and agencies with secure bicycle parking, repair stations, skateboard racks, and funding for artistic bicycle racks. The previous guidelines contained information on the type of racks that are eligible as well as the program requirements to apply for the program. The program runs on a \$30,000 budget per year with applications being reviewed on a first come first serve basis. However, funding for the program has not been fully utilized in previous years.

The 2021-2022 update of the former Bicycle Secure Program would broaden the program with additional program areas that are intended to increase the access of active transportation modes across Monterey County. The updated guidelines would be revised to include these Program Areas:

- Roll Repair Program:
 - The Transportation Agency would provide maintenance tools and training resources to schools and non-profit organizations to run their own maintenance program.
- Bike Support Kits:
 - The support kits would include a range of maintenance and safety items such as bike pumps, patch kits, inner tubes, lights, and reflectors.
- .Walk Support Program
 - This program seeks to utilize low impact, low cost walk safety improvements like signs, paint and banners

to create safer sidewalks and pedestrian areas around schools and participating organizations.

- League of American Bicyclists Training:
 - The Transportation Agency is seeking to partner with local schools and non-profit organizations to host training workshops to train prospective instructors about bicycle safety and education.
- Racks and Lockers:
 - Already in the existing program, the purchase and shipment of bicycle, scooter, skateboard racks and lockers would be provided to businesses and organizations interested in the equipment.

Each of the program areas has their own program requirements respectively.

Staff requests input from Committee members on the "Active Transportation Support Program" guideline updates. See the attached draft for changes made to the guidelines.

Once staff has received and incorporated input from the Bicycle and Pedestrian Facilities Advisory Committee, the updated guidelines will go to the Transportation Agency for Monterey County Board of Directors for approval.

In response to CalBike's new equity-related petition https://twitter.com/BikeMonterey/status/1462133307353677828? s=20, today I updated my 2016 "Local Ordinances" post just a bit (e.g., updated the Greenfield code links, which no longer worked) since I was referring to that post anew on Twitter https://twitter.com/BikeMonterey/status/1462137820395438081? s=20.

For new TAMC staff member Aaron and others who may have missed that 2016 post https://bikemonterey.org/local-ordinances-on-sidewalk-riding-and-more.html (and my 2018 related piece in Greenfield paper encouraging advocating for bike-friendly local ordinances https://bikemonterey.org/advocate-for-bike-friendly-local-ordinances-in-gonzales-and-elsewhere-in-monterey-county-california-or-wherever-you-live.html), I wanted to bring it to your attention now.

Also, as I've mentioned to BPC before (e.g., a spring 2021 public comment), **Bike** League opposes local ordinances that require licensing and registration, and there are some such local ordinances on the books in Monterey County. To learn more, see my April 2021

Pebble Beach concerns

On Nov 12 I heard from Pebble Beach Company that they've seen an increase in inappropriate behavior by people who bike, and that they'd appreciate the bike community helping to educate. Since 2010 I share tips on biking PB, and since 2012 I emphasize PB residents' primary concerns (bullet points at top) in https://bikemonterey.org/biking-17-mile-drive.html. I encourage anyone on social media to share a link to that post. Unfortunately some local bicycling and tourism-related businesses and organizations share misinformation or no information. My post was initially developed in coordination with their now-retired safety director and was updated this month in coordination with their security director—who also alerted me that, because of multiple complaints, they will be doing a push to have CHP issue more citations to people biking who are ignoring stop signs or other traffic laws. People who bike do sometimes call me when they've received such citations,

e.g. https://twitter.com/BikeMonterey/status/1367270150102077440?s=20. And as you know, the governor vetoed the Safety Stop Bill this fall, so people on bikes are still required by law to stop at stop signs. https://bikemonterey.org/bicycle-safety-stop-californias-ab-122.html

Besides outreach to tourists and adult residents, this topic could be good for SRTS presentations at schools too, especially middle and high schools, since many teens use skateboards and scooters for transportation, as I mentioned in my public comment to the MC Board of Supervisors 9/14/21, and in my letter to the
