**WHEREAS**, the American Association of State Highway and Transportation Officials (AASHTO) established the United States Bicycle Route System (USBRS) in 2008; and

**WHEREAS**, the Adventure Cycle Association (ACA) along with the American Association of State Highway and Transportation Officials (AASHTO) is developing a network of bicycle touring routes throughout the country; and

WHEREAS, the ACA manages the USBRS designation process nationally for AASHTO and has been working with local agencies to obtain endorsements for United States Bicycle Route 95 (USBR 95); and

WHEREAS, AASHTO has designated a bicycle corridor through the County of Monterey to be identified as United States Bicycle Route 95 (USBR 95) that runs along the West Coast from Canada to Mexico; and

**WHEREAS,** USBR 95 will provide a route for cyclists to travel south from the Oregon/California border, down to the California/Mexico border; and

**WHEREAS**, there are over 1000 miles of the route along the California coast and Caltrans has formally approved the routes along the California State highway system; and

WHEREAS, the route follows streets, roads, and bike paths in the County of Monterey, transitioning from the County of Santa Cruz, traveling through Pajaro, Castroville, City of Marina, City of Monterey, and City of Carmel, towards San Luis Obispo County; and

WHEREAS, the route through the unincorporated region continues from the County of Santa Cruz and the City of Watsonville, across the Porter Bridge onto Porter Drive and Salinas Road through Pajaro to Hilltop Road, onto State Route 1, towards Molera Road and Merritt Street through the Castroville area, towards Monte Road and Del Monte Road, through the City of Marina and other peninsula cities, through the City of Monterey, onto State Route 1 and onto Carpenter Street and Serra Avenue through the City of Carmel and onto Rio Road, and onto State Route 1 south towards the County of San Luis Obispo.
